

Sealed Tender accompanied with earnest money of Rs.1000/- (Rupees One Thousand) only for each Vehicle separately in shape of Bank Draft in favour of Under Secretary to Govt., ST & SC Development Department, Odisha Secretariat payable at UCO Bank, Odisha Govt., Secretariat Branch, Bhubaneswar should reach the undersigned on or before 15.10.2020 by 3.00 P.M. The Tenders so received shall be opened by the Tender Committee of this Department on the same day i.e. 15.10.2020 at 4.00 P.M. in the in the conference Hall of ST & SC Development Department, in the presence of tenderer or their authorized agency. The earnest money shall be refunded to the unsuccessful tenderer after finalization of the Tender.
2. The intending tenderer may inspect the vehicle parked in the Exhibition Ground, Unit-I, Bhubaneswar during office hours on any working days before filling the tender.
3. The highest tenderer or whose tender will be accepted shall deposit 25% of the offered amount for each vehicle immediately after the sale is confirmed and deposit the rest amount within 07(seven) days from the date of acceptance of the tender failing which the deposited amount along with the earnest money will be forfeited.
4. The Tenderer/ Party shall remove the vehicle(s) from the site within 07 days from the date of depositing the full amount of tendered/ negotiated money. Custody of safeguard of the vehicles shall be the responsibility of the tenderer/ party and no claim or complaint on that amount shall be admissible.
5. On failure to remove the vehicle(s) from the site within 07(seven) days, Ground Rent@1% of the tendered/ negotiated money shall be charged for each any or part of the day till the vehicle(s) is/are removed.
6. If the Ground Rent so charged exceed the sale price deposited, the tenderer/ party shall cease to have any right on the vehicle(s) and it shall become absolute property of the Govt. and amount deposited by him shall be adjusted towards ground rent.
7. No Government Servant is permitted to participate in the Tender Process for Auction Sale of the Condemned Vehicle.
